During the delivery of regular programming they will require no direct supervision or support and will be actively involved in supporting and assisting other Instructors

Assist all other HOEC staff in ensuring that all other HOEC resources - Land/buildings/vehicles etc. are used, treated and cared for to ensure safety, cleanliness, and longevity.
